WHEREAS, James M. Perry the said James M. Perry SEND GREETING:

in and by certain note in writing, of even date with these presents, well and truly indebted to Mrs. Eva St. Anderson and Eunice J. Andrea in the full and just sum of Five Hundred (\$500.00)

Dollars, to be paid with interest thereon from date with the right to prepay at any time without penalty or any interest date.

with interest thereon from at the rate of 7 per cent. per annum, to be computed and paid semi-annually

until paid in full and interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mrs. Eva St. Anderson and Eunice J. Andrea

A certain lot of land situate lying and being in Greenville Township, Greenville County, South Carolina, on the North side of Sidney Street near the Fair Mountain Road, being known as lot #5 on plat of property of James M. Perry, recorded in Plat Book # page 127, R. M. C. Office for Greenville County, and being more particularly described as follows:

Beginning at a stake on the North side of Sidney Street joint corner of lots #4 and #7 and running thence along Sidney Street S 88° 20' 20" 30 feet to a w. iron pin, thence along line of lot #6 North 31° 30' 20" 150 feet, thence North 88° 30' 00" 50 feet to a w. iron pin, thence along line of lot #7 South 31° 30' 00" 150 feet to the point of beginning.
