 a Corporation chartered under the laws of the State of S.C.
 in and by its certain promissory note in writing, of even date with these presents,
 is in full and just sum of Four thousand,

nine hundred fifty three dollars, to be paid as follows: \$1,000 in 60
 days after date; one thousand dollars in 4 months after date; \$1,000 in 4
 months after date; one thousand dollars in 5 months after date; \$953 in 6
 months after date, one thousand dollars at the rate of 8
 per centum to be computed and paid, until paid in full; all
 interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount
 evidenced by said note to become immediately due, at the option of the holder hereof, to make thereon and foreclose this mortgage; and in case said note, after
 its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the
