with interest thereon, from the date at the rate of 8 per cent. per annum, to be
computed and paid semi-annually
interest be at any time past due and unpaid, until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
who may sue thereon and for the whole amount advanced by said note, to become immediately due at the option of the holder hereof,
added to the amount due on said note, to be collectible as a part thereof, the same be placed in the hands of an attorney for collection, or if said debt, or any
being thereof collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference

bargain, sell, and release unto the said Bessie Norris Tilman, all that lot of land with improvements
situate in the State and County aforesaid, situate just beyond the corporate
limits of the City of Greenville on the extension of North Street or Spartanburg Road,
having the following metes and bounds, to-wit:
Beginning at an iron pin on the North side of Lot number 5 of W. A. Bates property, and
running thence N. 18-14 W. 308 feet to an iron pin on line of said W. A. Bates property;
thence N. 75-55 E. 55 feet to an iron pin, corner of lot No. 2; thence S. 18-14 E. 308
feet to an iron pin on Spartanburg Road; thence S. 75-55 W. 55 feet to the beginning.
This being Lot No. 1 of property of Chandler and Ballenger as shown by plat recorded in
Plat Book "C", page 270 R.M.C. Records for Greenville County. On the above described lot
there is situate a seven-room, two-story dwelling which is my present home and this
