Thorsen, in and to the land described below, being a certain piece or lot of land situate, lying and being in the State of South Carolina, County of Greenville and in Greenville Township, City of Greenville in Ward One on the North side of Randall Street and being part of Lot Number Twelve of Section "A" of a tract of Stone Land Company, said tract recorded in Plat Book "A" pages 337-345, said lot has a frontage on Randall Street of Ascenty feet with a depth of One hundred fifty feet and being part of one of the lots formerly owned by the Stone Land Company and described by metes and bounds as follows, to-wit:
