SEND GREETING:

WHEREAS, *R. J. Blae*, the said *R. J. Blae*  
 in and by *me* certain *promise*,  
 even date with these presents, *1921*,  
*Maurie S. Anderson*  
 in the full and just sum of *three hundred (300) dollars*  
 Dollars, to be paid *one year from the date hereof*

with interest thereon, from *date* *1921*, at the rate of *3% per annum*, per cent. per annum, to be  
 computed and paid *1921*.

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
 interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due at the option of the holder hereof, who  
 may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent (10%)*  
 besides all costs and expenses of collection to be  
 added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any  
 part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference  
 being thereunto had, as will more fully appear).

NOW, KNOW ALL MEN, That *R. J. Blae*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said  
*Maurie S. Anderson*

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to *me*, the said  
*R. J. Blae*  
 in hand well and truly paid by the said *Maurie S. Anderson*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,  
 bargain, sell and release unto the said

*Maurie S. Anderson*, all that certain piece, parcel or lot  
 of land, situate, lying and being on Summit Drive,  
 about two miles south of the City of Greenville, County  
 and State aforesaid. Beginning at the joint corner  
 of Mahaffey and Mrs. Maurie S. Anderson's line,  
 the Grantor herein, and running in a eastward direction  
 along the joint line of Mahaffey and the Grantor herein,  
 three hundred (300) feet to a corner; thence sixty-eight (68)  
 feet in a northward direction parallel to the line on  
 Summit Drive to a corner; thence three hundred (300)  
 feet in a western direction parallel to the said joint  
 Mahaffey-Anderson line on Summit Drive to a corner;  
 thence in a southward direction along Summit Drive  
 forty-eight (68) feet to the beginning corner on Summit Drive.
