with interest thereon, from date at the rate of seven per cent. per annum, to be computed and paid annually.

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent.

besides all costs and expenses of collection to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear).

piece, parcel or tract of land situate, lying and being in Saluda Township, State and County aforesaid, on Rutherford Road and water of Musch Creek, having the following mites and bounds, to wit; Beginning at a stone and running thence N 17-1/2 E. 23.88 to a stone thence N 79-1/2 E. 23.00 to a stone in the Rutherford Road thence along the said road to the beginning corner, containing twenty-seven and one half (27 1/2) acres, more or less.

Also all that certain piece, parcel or tract of land situate, lying and being in Saluda Township, State and County aforesaid, on Rutherford Road and water of Musch Creek, and adjoining the tract first above mentioned, and having the following mites and bounds, to-wit: beginning on a stone in the Rutherford Road and running thence 80-3/3 E. 27.93 chs. to a stake 3X; thence N 10-1/2 E. 23.78 chs. to a stake 3X; thence N 80 W 2.25 chs. to a stake in Rutherford Road; thence along said road 33.75 chs. to the beginning corner, containing forty and three-fourths (40 3/4) acres more or less.
