And the said Mortgagor agree to insure the house and buildings on said lot in a sum not less than

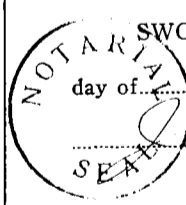

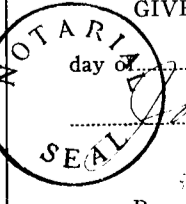
