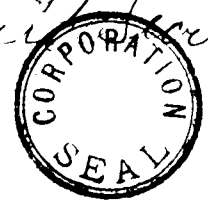
NOW KNOW ALL MEN BY THESE PRESENTS, that I the said Iola F. Lapham
