 of Greenville, in the County of Greenville, State of South Carolina, on the
 East side of Grove Road, and being known as a tract or lot No. 68, on
 a plat of North Cherokee Park, said tract recorded in R.M.C. Office for
 Greenville County, in Plat Book "C" at page 96, and having according
 to a plat thereof prepared January 15th, 1930, by C. M. Furman, Jr.
 Engineer. The following metes and bounds, courses and distances, to-wit:
 Beginning at a point on the East side of Grove Road, said point
 being at the Southeast corner of the intersection of Grove Road and
 Cherokee Road, and running thence with the Eastern side of Grove Road
 S. 18° 48' W. 64 feet to an iron pin; thence S. 62° 32' E. 170 feet, 5 inches
 to an iron pin; thence N. 18° 48' E. 92 feet to an iron pin on the
 Southern side of Cherokee Road; thence along the Southern side of
 Cherokee Road N. 72° 40' W. 169 feet 2 inches to an iron pin, the
 point of beginning. Being the same lot of land conveyed to the
