I, Jane G. Huntington

- All those certain lots of land situate in the city of Greenville, State of South Carolina of Anglewood Street - lots nos. 23 and 24 and Terrace having according to a plat prepared by C. M. Sherman, Jr., Engineer, January 15th 1929 the following courses and distances, to-wit:

Beginning at an iron pin on the north side of Anglewood Street, joint corner of lots nos. 24 and 25, said pin being 110 feet East of M.
