WHEREAS, the said S.B. and WHEREAS, all of said notes are dated the 21st day of December, 1926, and are signed by Southern Bond and Mortgage Company, Inc. at the office of said company, Richmond, Virginia, in gold coin of the United States of America of present standard of weight and fineness, and it is agreed that any said notes are not paid on the maturity dates named therein the said note or notes so unpaid shall bear interest after maturity at the rate of eight per centum per annum.  
NOW, KNOW ALL MEN, that the said S.B. Eskew, hereinafter sometimes referred to as Mortgagor), in consideration of the said debt and sum of money aforesaid and for the better securing the payment thereof, to the said Southern Bond and Mortgage Co., Inc., according to the terms of said notes, and also in consideration of the further sum of Three Dollars to... in hand well and truly paid by the said Southern Bond and Mortgage Co., Inc., at and before the signing of these presents, receipt whereof is hereby acknowledged, have granted, bargained, sold, aliened, released, and by these presents do grant, bargain, sell and release unto the said SOUTHERN BOND AND MORTGAGE COMPANY, INC.'S SUCCESSORS AND ASSIGNS (hereinafter sometimes referred to as Mortgagee),

all that certain parcel or tract of land and being, being and situated in Farwell Township, Greenville County, State of South Carolina, and more particularly described as follows, beginning at a point marking the northwestern corner of the above described tract, which point marks corner of lands now or formerly owned by S.M.
