we, J. N. Scott and Effie Scott
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the
sum of *\$ 7.67* Dollars, (*\$ 5.00*

Dollars, being the regular monthly payment on said stock and *\$ 2.67* Dollars, being the monthly interest on balance due);
for the next twenty months the sum of *\$ 7.00* Dollars, (*\$ 5.00*

Dollars, being the regular monthly payment on said stock and *\$ 2.00* Dollars, being the monthly interest on balance due); for the next twenty months pay the
sum of *\$ 5.00* Dollars, (*\$ 5.00*

Dollars, being the regular monthly payment on said shares of stock and *\$ 6.33* Dollars, being the monthly interest on balance due); for the next twenty months pay the
sum of *\$ 1.33* Dollars, (*\$ 5.00*

Dollars, being the regular monthly payment on said shares of stock and *\$ 1.33* Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said
