of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *J. J. Meadows*, the said *J. J. Meadows* in and by *My* certain note or obligation, bearing date the *21st* day of *April* 192*6*

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Thirty eight hundred (\$3800.00)* Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the *21st* day of *April* A. D. 192*6*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that *J. J. Meadows* the said *J. J. Meadows* shall pay or cause to be paid to the said

Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *May* 192*6*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *\$63.33*

Dollars, (*\$38.00* Dollars, being the regular monthly installment payable on the *38* Shares of Stock, and *\$25.33* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the

sum of *\$58.27* Dollars, (*\$38.00* Dollars, being the regular monthly payment on said stock and *\$20.27* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *\$53.30* Dollars, (*\$38.00* Dollars, being the regular monthly payment on said stock and *\$15.30* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *\$48.05* Dollars, (*\$38.00* Dollars, being the regular monthly payment on said shares of stock and *\$10.05* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *\$43.07* Dollars, (*\$38.00* Dollars, being the regular monthly payment on said shares of stock and *\$5.07* Dollars, being the monthly interest on balance due.)

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land situated in the County of Greenville, State of South Carolina, and described as follows:

*In Greenville Township about West of Greenville Court 4 houses and 1/2 mile West of Greenville Court at house and 1/2 mile West of Greenville Court Lot No. 5 of Block "C" of Plat recorded in Plat Book "E" Page 2098 and having the following meter and bounds:*

*Beginning on N. E. Corner of Texas Avenue and Earley Bridge Road; thence with Earley Bridge Road N. 71 E. 80 feet to corner of Lot # 4; thence with line of lot # 4, north 179.7 feet to line of lot # 6; thence with S. line of lot # 6 S. 71 W. 88 feet to Texas Avenue; thence with Texas Ave S. 22-10 E. 180 feet to beginning corner and being the same lot conveyed to me by Lodging Co.
