indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Five Hundred Fifty (550.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly from the *19th* day of *April* A. being the regular monthly installment (payable on the *1st* day of *April* 192*6*) on *Five* Shares of Stock, and *3.07* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *8.50* Dollars,

being the regular monthly payment on said stock and *1.18* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *7.70* Dollars,

being the regular monthly payment on said stock and *2.70* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *6.97* Dollars,

being the monthly payment on said shares of stock and *1.40* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *6.23* Dollars,

being the monthly payment on said shares of stock and *1.40* Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *542* shares of stock and the certificate thereon the amount at such time paid shares to be credited as a payment upon the advance or loan made *me*, the said *J. St. Nealey*

and shall pay or cause to be paid all fines which may be duly imposed upon or charged against the said *J.
