TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, D. H. Hollybee
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said D. H. Hollybee
in and by my certain note or obligation, bearing date the 27th day of May 1926

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of Six hundred (\$600.00) Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 27th day of May A. D. 1926

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
the said D. H. Hollybee shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of June
1926, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of \$10.00

Dollars, (\$6.00 Dollars, being the regular monthly installment payable on the Six (6) Shares of Stock, and \$4.00

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the
sum of \$9.20 Dollars, (\$6.00

Dollars, being the regular monthly payment on said stock and \$3.20 Dollars, being the monthly interest on balance due);
for the next twenty months the sum of \$8.40 Dollars, (\$6.00

Dollars, being the regular monthly payment on said stock and \$2.40
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$7.60

Dollars, being the monthly payment on said shares of stock and \$6.80 Dollars, being the monthly interest on balance due); for the next twenty months pay the
sum of \$6.80 Dollars, (\$6.00

Dollars, being the monthly payment on said shares of stock and 20 cents Dollars, being the monthly interest on balance due.)
Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Six

shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the
said D. H. Hollybee

and shall pay or cause to be paid (all fines which may be duly imposed upon, or charged against me the said D. H. Hollybee
said note or obligation, and the condition thereunder written, reference being thereunto, had will more fully appear.

NOW, KNOW ALL MEN, That I the said D. H. Hollybee
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Com-
pany, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

*all that certain lot of land in Greenville Township
Greenville County, South Carolina being a part of lots numbers
fifty-five and fifty-six (55 and 56) of Price and Patton and
Company, plat recorded in Plat Book "E" page 249, and
said lots have the following meter and bounds: Beginning
on East side of Valley Street 57.8 feet north of Heatherly
Drum and running thence with Valley Street N 36-56 E
50 feet to corner of R. A. Lundsford's lot; thence S 59-
23 W. 100 feet, more or less to line of lot no. 54; thence
S 36-15 W. 50 feet; thence N 59-23 W. 100 feet to the
beginning corner, and being the same lot conveyed to
