TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Mamie Green
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, I, Mamie Green,
in and by my certain note or obligation, bearing date the 10th day of July 1926
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of One hundred fifty & no/100 (\$150.00) Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 10th day of July A. D. 1926,
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
I the said Mamie Green shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of July
1926, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of \$2.50
Dollars, (\$1.50 Dollars,
being the regular monthly installment payable on the 1-1/2 Shares of Stock, and \$1.00
Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the
sum of \$2.30 Dollars, (\$1.50
Dollars, being the regular monthly payment on said stock and \$0.80 Dollars, being the monthly interest on balance due);
for the next twenty months the sum of \$1.50 Dollars,
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$0.60
Dollars, (\$1.50 Dollars, being the regular monthly payment on said stock and \$0.10 Dollars, being the monthly interest on balance due);
for the next twenty months pay the sum of \$0.40 Dollars, (\$1.70 A. D. 1930 Dollars, being the regular monthly payment on said stock and \$0.20 Dollars, being the monthly interest on balance due);
for the next twenty months pay the sum of \$0.20 Dollars, (\$1.50 Dollars, being the regular monthly payment on said stock and \$0.20 Dollars, being the monthly interest on balance due).
Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 1-1/2

hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

near the City of Greenville and being known and designated
as Lots nos twenty (20) twenty-one (21) and twenty-two (22)
of the J. R. West property and shown on plat of said property

Office for Greenville County. Said lots have an aggregate front-
age on an unnamed Street of one hundred ninety five & 5/10
