

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, John H. Anders  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:  
WHEREAS, I, the said John H. Anders  
in and by myself certain note or obligation, bearing date the 17th day of September 1926  
I am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,  
duly incorporated under the laws of such State), in the sum of Two Thousand and no/100 (\$2,000.00) Dollars,  
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 17th day of September A. D. 1926;  
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that  
the said John H. Anders shall pay or cause to be paid to the said  
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of October  
1926, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of \$33.33  
\$33.33 Dollars, (\$2000.00 Dollars,  
being the regular monthly installment payable on the Twenty (20) Share of Stock, and \$33.33  
Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the  
sum of \$30.67 Dollars, (\$2000  
Dollars, being the regular monthly payment on said stock and \$10.67 Dollars, being the monthly interest on balance due);  
for the next twenty months the sum of \$28.00 Dollars, (\$2000  
\$20.00 Dollars, being the regular monthly payment on said stock and \$8.00  
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$25.33  
\$20.00 Dollars, being the monthly payment on said shares of stock and  
\$5.33 Dollars, being the monthly interest on balance due); for the next twenty months pay the  
sum of \$22.67 Dollars, (\$2000  
\$2.67 Dollars, being the monthly payment on said shares of stock and \$20.00 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said  
shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made to  
the said John H. Anders  
and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against I the said John H. Anders  
John H. Anders in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the  
said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear, and by the  
NOW, KNOW ALL MEN, that I, the said John H. Anders, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Com-  
pany, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to  
the said John H. Anders  
in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is  
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and  
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Designated as Lot no. 1 in sub-division of Property  
of J. M. Clark, as shown by plat dated April 1923  
Beginning at an iron pin on the Parker Road, cor-  
ner of Lots 1 and 2, and running N. 38 E. 180 feet along  
line of Lot no. 2 to an iron pin, thence S. 25-36 E. 405-4  
feet to an iron pin in Parker Road; thence  
North west with Parker Road 381.5 feet to the beginning  
and being the same lot of land conveyed to me by  
J. M. Clark by deed dated February 3rd, 1925, and  
recorded in Deed Book 77, Page 204, R. M. C. Office  
for Greenville County, South Carolina.
