PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if *I* the said mortgagor, shall well and truly pay, or cause to be paid, unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, its certain Attorney, successors or assigns, the said debt or sum of money aforesaid with interest thereon, if any shall be due, according to the true intent and meaning of the said Bond and Condition thereunder written, then this deed of bargain and sale shall cease, determine and be utterly null and void; otherwise, it shall remain

in full force and virtue. And it is agreed, by and between the said parties, that the said mortgagor *her* Heirs, Executors or Administrators, shall and will insure the House and Buildings on said lot in the sum of not less than \$ *300.00*

and keep the same insured from loss or damage, by fire, and assign the Policy of Insurance to the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, and that in case *he* shall at any time neglect or fail to do so, then the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, may cause the same to be insured in its own name, and reimburse itself for the premium and expenses of such insurance under this mortgage.

AND IT IS AGREED, by and between the said parties, that in the case of default of payment under any of the conditions of the said Bond, for the space of three consecutive months, it shall be lawful for the said Citizens Building and Loan Association, of Greenville County, South Carolina, to begin legal proceedings, or at its option after three weeks' publication in one of the newspapers of the City of Greer, to sell the property hereby mortgaged at public auction, and apply the proceeds of sale to the extinguishment of the debt under this mortgage, and the payment of all costs and expenses, including Attorney's fees, incurred by such sale, and the Bond intended to be secured thereby, returning the overplus, if any, to the said mortgagor, unless the same shall be claimed by a judgment or other mortgage creditor of the said mortgagor, and for the purpose of such sale, the said mortgagor hereby appoints and constitutes the President of the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, and his successors in office, or assigns of said Corporation, or its successors

*her* attorney or attorneys for *her* and in

*her* name to execute and deliver proper titles to the purchaser or purchasers for the premises sold,

AND IT IS FURTHER AGREED, by and between the said parties, that the mortgagor shall hold and enjoy the said premises, until default of payment shall be made.
