THIS INDENTURE, made this 5th day of October A. D. 1926

by and between Sue Parker

WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of Two thousand Dollars, money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly,

the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

In the city of Greenville, on the East side of David Street, and having the following sites and bounds, to-wit: Beginning at an iron pin on the East side of David Street at the corner of an alley, now Stratham Street, and running thence N. 89. E. 128 1/2 feet to an iron pin; thence N. 14 1/4 W. 97 feet to Pin, corner of lot heretofore conveyed to Mrs. Lila Baker; thence with her line S. 72 W. 135 feet to Pin on David Street; thence with David Street S. 24 E. 62 feet to the beginning corner, being one of the lots of land conveyed to me by R. A. Parker by his deed dated August 21, 1926, and recorded in the R. M. C. office for Greenville County in Deed Book volume 118, Page 440.
