SEND GREETING:

WHEREAS, *S. Fulton F. Bzgere*, the said *Fulton F. Bzgere*
in and by *1221* certain *1221* note in writing, of
even date with these presents, well and truly indebted to Pioneer Life Insurance Company
in the full and just sum of *Five hundred and twenty five dollars (\$525.00)*
Dollars, to be paid *in three installments of one hundred and seventy five dollars (\$175.00) each*
the first installment being due on the 1st day of January 1930
the second installment being due on the 1st day of April 1930
the third installment being due on the 1st day of July 1930
with interest thereon, from *1929* at the rate of *seven and one-half* per cent. per annum, to be
computed and paid *semi-annually*
