piece, parcel and tract of land situate lying and being in Austin Township, County and State aforesaid, bounded by lands of M.M. Gaines, S.J. Bell, May R. Kilgore and others, consisting of two tracts of 27.45 acres and 35 acres, a total of 62.45 acres, and being the same land conveyed to me by Mrs. Mary M. Kilgore by deed dated Aug. 5th, 1924 and recorded in the office of R.M.C. for Greenville County in Vol. 83, at page 281.
