all that certain piece, parcel or lot of land situate,
 lying and being in the State of South Carolina,
 County of Greenville, being in the City of Greenville,
 at the Southeast corner of Byncombe Street and
 Butler Avenue, the said being described by metes
 and bounds as follows:
 Beginning at said Southeast corner of Byncombe
 street and Butler Avenue and running thence
 along the Western line of Byncombe Street south
 34 deg. East One hundred Twenty and $\frac{1}{2}$ feet to a
 stake, thence South 55 deg. 51 min. West one hundred
 two and $\frac{1}{2}$ feet to a stake; thence South 4 deg. 02
 min. West Forty three and $\frac{1}{2}$ feet to a stake on
