On the East side of Westfield Street, beginning at a point on said street 65 feet from Washington street and running thence S. 64 deg. E. eighty one and one tenth feet; thence S. 20 3/4 W. eighty feet; thence in a straight line to Westfield Street to a point eighty three feet from the beginning corner; thence along said street N. 21 deg. E. eighty three feet to the place of beginning; being a part of the lot of land heretofore conveyed to Mrs. Ella D. Barr by deed of T. W. Barr of record in Vol. 7. 7. 7. at page 308.
