Dollars, to be paid *one year after date*

with interest thereon, from *date in* at the rate of *8* per cent. per annum, to be
computed and paid *annually*

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent*
besides all costs and expenses of collection to be
added to the amount due on said note. To be collectible in part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
part thereof, be collected by an attorney or by legal proceedings of any kind (out of which is secured under this mortgage, as in and by the said note, reference
being thereunto had, as will more fully appear)

bargain, sell and release unto the said *C. F. Putman*, all that piece, parcel or lot

of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, on the North side of Early Bridge Road, having the following metes and bounds according to a plat of Highland, made by W. D. Newy, Engineer, and recorded in the R. M. C. Office for Greenville County in Plat Book "C" At page 146. Beginning at an iron pin on north side of Early Bridge Road, corner of lot No. 5. And running thence N. 15-10 W. 127.7 feet to an iron pin on ten foot Alley, thence along ten foot Alley S. 73 W. 65 feet to an iron pin on Carolina Avenue, thence along Carolina Avenue S. 15-10 E. 129.8 feet to Iron pin on north side of Early Bridge Road, thence along north side of Early Bridge Road N. 73 E. 65.1 feet to the beginning corner, being known and designated as lot No. 6 on said plat, being the same lot of land conveyed to me by C.
