KNOW ALL MEN BY THESE PRESENTS, That of the County and State aforesaid, hereinafter called parties of the first part, whether one or more, SEN. GREENE, INC.

WHEREAS, the said parties of the first part are indebted in and by a certain promissory note of even date herewith for the principal sum of

One Thousand Dollars

(\$ 1,000.00) Dollars, payable to the order of Atlantic Joint Stock Land Bank of Raleigh, a corporation created, organized and existing under and by virtue of an Act of Congress of the United States of America, entitled "The Federal Farm Loan Act," bearing interest at six (6%)

per centum per annum from date and payable semi-annually,

both principal and interest being payable on an amortization plan, in sixty-five (65)

semi-annual installments of

(\$ 35.00) Dollars and

cents each, and a final installment of

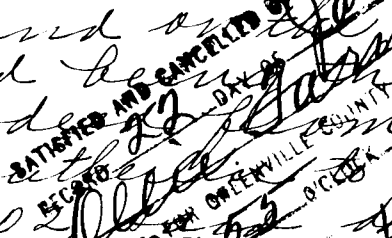
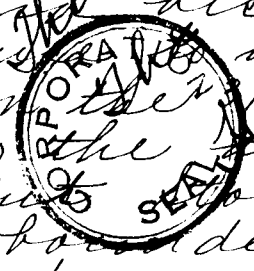
(\$ 29.20) Dollars and

cents, the first installment being payable on the first day of February 1928 and the next installment on the

first day of February 1928 and each successive installment on the same day of each succeeding year thereafter until the entire principal sum is paid in full, and providing that in the event of default in the payment of any installment or installments in accordance with the terms thereof, the same shall bear simple interest from date of such default until paid at the rate of eight (8%) per centum per annum, and providing further that after five years from date, and on any regular installment date, an additional payment on the principal may be made in such an amount as shall be equal to one or more of the annual payments on the principal as ascertained from the amortization tables prescribed by the Federal Farm Loan Board, or the entire principal sum may be paid; all of which and such other terms as therein contained, will more fully appear by reference to said note.

NOW, KNOW ALL MEN, That the said parties of the first part of the County and State aforesaid, in consideration of the debt as evidenced by said note, and for the better securing the payment thereof to the said Atlantic Joint Stock Land Bank of Raleigh according to the terms of said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to the said parties of the first part in hand well and truly paid by the said Atlantic Joint Stock Land Bank of Raleigh, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said Atlantic Joint Stock Land Bank of Raleigh, its successors or assigns.

All that certain piece, parcel or tract of land, containing fifty and three-fourths (55 3/4) acres, more or less, about twenty-one miles from the City of Greenville in Highland Township, Greenville County, State of South Carolina, having such shape, metes, courses and distances, as will more fully appear by reference to a plat thereof, made by W.D. Nixey, C. E., on the 1st day of January, 1927, and attached to the abstract now on file with the Atlantic Joint Stock Land Bank of Raleigh, the same being bounded on the North by the lands of D.H. Bates, on the East by the lands of B.J. Stewart and R.A. Southerlin and on the South by the lands of R.A. Southerlin and on the Southwest by the land of Alustine Wood, and being an identical tract of land conveyed by deed from D.H. Bates and Lillie N. Southerlin to Laura A. Southerlin, dated May 9, 1902, and being duly recorded in Deed Book No. 178, at Page 725, in the office of the Register of Merit Conveyance for Greenville County, State of South Carolina, to which reference is made for a more complete description of the same.



#4511, For value received, and without recourse on us in any event, we, the Atlantic Joint Stock Land Bank of Raleigh, hereby transfer, sell and assign to the Federal Land Bank of Columbia, of Columbia, South Carolina, for itself and/or as agent of the Land Bank Commissioner, and its successors and assigns, all our right title and interest in and to that certain and attached note and mortgage deed from Laura A. Southerlin, to us, dated February 14, 1927, in the original sum of \$1,000.00 said mortgage being recorded in book 178, at page 32, in the office of the Clerk of Court for Greenville County, South Carolina, and covering one tract of land in Highland Township said County and State. In witness whereof, the said Atlantic Joint Stock Land Bank of Raleigh has caused its name to be signed hereto by its Vice-President and attested by its Assistant Secretary, and its corporate seal affixed thereto, all by order of its Board of Directors, this 11th day of June, 1934, and in the one hundred and fifty eighth year of the Sovereignty and Independence of the United States of America.
