SEND GREETING:

WHEREAS, I, Ella M. Alford, the said Ella M. Alford,
in and by my certain Promissory note in writing, of
even date with these presents, am well and truly indebted to
P. C. Poag

in the full and just sum of Five Hundred Dollars (\$500.00)
Dollars, to be paid one year after date with the Privilege of Anticipating
Payment at any interest period

with interest thereon, from date at the rate of 8 per cent. per annum, to be
computed and paid Semi-Annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal
or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten Per cent (10%)

besides all costs and expenses of collection to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference
being thereunto had, as will more fully appear.)

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,
bargain, sell and release unto the said P. C. Poag

All that certain Piece, Parcel or lot of land situate, lying
and being in the state of South Carolina, County of Green-
ville, and in the City of Greenville known and designated
as Lot no. 11, Block "m" according to map or Plat of the O. P.
Mills Property of record in Plat Book "C" at Page 176 in the
R. M. C. Office for Greenville County, South Carolina, reference
to which Plat is hereby made; said lot of land being de-
scribed by metes and bounds as follows, to-wit:
Beginning at an iron Pin on the Southwestern line of
Augusta Street; North 48 deg. 22 min. West 72.74 feet from
the intersection of the Northern (North-Western) line of
Grove Road with the southwestern line of Augusta Street,
and running thence South 45 deg. 27 min. 180 feet to
an iron Pin on the Northeast line of Lot no. 13 according
to said Plat; thence along the Northeast line of said lot
no. 13. North 48 deg. 22 min. West. 72 feet to an iron Pin
at the Corner of Lot no 10; thence North 45 deg. 27 min. East
180 feet to the Southwestern line of Augusta Street; thence
with the Southwestern line of Augusta Street South 48
deg. 22 min. East 72 feet to the Place of beginning, and
being the same lot of land conveyed to me by W. J.
Henderson and C. B. Martin by their deed dated April 13th
