computed and paid *Annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal
or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten Per cent.*

All that certain Piece, Parcel or tract of land situate, lying
and being in the County and State aforesaid, in Grove
Township, containing 131 acres, more or less, bounded by
lands of Dr. C. G. West, Tom Harrison, Miss Grace Pepper,
Mrs. Charles and Others; Beginning at a stone on Grove
Road, at the corner of lands owned by Tom Harrison and
Wade Pepper's Estate, and running thence with said road
N. 29 1/2 E. 60 chs. to stone; thence N. 48 1/2 W. 1.60 chs. to a stone;
thence N. 1 1/2 E. 11.31 chs. to a stone; thence S. 77 1/2 W. 24.85
