PROVIDED, ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if George Norwood the said mortgagor George Norwood, do and shall well and truly pay or cause to be paid unto the said mortgagee George Norwood the debt or sum of money aforesaid, with interest thereon, if any be due, according to the true intent and meaning of the said note George Norwood, then this deed of bargain and sale shall cease, determine and be utterly null and void, otherwise to remain in full force and virtue.
