in the full and just sum of three Dollars, to be paid three years after date

with interest thereon from the date of this instrument at the rate of 7 per cent. per annum, to be

computed and paid monthly at the rate of 7 per cent. per annum, to be

paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at

any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon

and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagee promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

all that certain piece, parcel or lot of land in Greenville Township, County and State of aforesaid, in City View Annex, and being lot no. 46, as shown on plat of said City View Annex, recorded in R.M.C. office for Greenville County in Plat "Book" G, pages 152-155, reference being made for a more complete description.
