KNOW ALL MEN BY THESE PRESENTS, That

L. Grover B. Jones

of the County and State aforesaid, hereinafter called parties of the first part whether one or more, SEND GREETING:

WHEREAS, The said parties of the first part are indebted by a certain promissory note of even date herewith for the principal sum of Fifty hundred and no/100

(\$ 1500.00) Dollars, payable to the order of The First Carolinas Joint Stock Land Bank of Columbia, a corporation created, organized and existing under and by virtue of an Act of Congress of the United States of America, entitled "The Federal Farm Loan Act," at its home office in the City of Columbia, South Carolina, together with interest thereon at the rate of

six (6) per centum per annum from date to and including the first day of

December, 1927, which said interest shall be

due and payable on said date and shall be known as the preliminary interest, installment, and thereafter with interest on the whole amount of said principal sum remaining from time to time unpaid at the rate of six (6) per centum per annum, payable semi-annually, both principal and interest being payable on an amortization plan as follows:

In sixty-five semi-annual installments of Fifty-two and 60/100 (\$52.60) Dollars, the first each, and a final installment of Forty-three and 80/100 (\$43.80) Dollars, the first

installment being payable on the first day of June 1928 and the next installment on the first day of December 1928 and the successive installments on the same days of each succeeding year thereafter until the entire principal sum is paid in full, and in the event default is made in the payment of any installment or installments, the same shall bear interest from the date of such default until paid, at eight (8) per cent. per annum, and providing, further, that after five years from date, and on any regular installment date, an additional payment on the principal, in such an amount that shall be equal to one or more of the semi-annual payments on the principal as ascertained from the amortization tables prescribed by the Federal Farm Loan Board, may be made, or the entire principal sum may be paid; all of which, and such other terms as therein contained, will more fully appear by reference to said note.

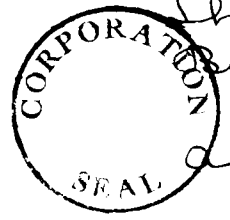

All that certain piece, parcel or tract of land containing thirty-nine (39) acres, more or less, located, lying and being in Fairview Township, County of Greenville, State of South Carolina being bounded on the north by the lands of Jim Evans, Byron Cox and A. D. Sweeney, East by the lands of G. H. Jones and A. D. Sweeney; South by the lands of H. D. Harkman and A. D. Sweeney; and West by the lands of H. D. Harkman and Jim Evans, and having such meters, shapes, courses and distances as will more fully appear by reference to a plat thereof made by H. J. Riddle Surveyor, May, 12, 1927.
