

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That we, Adeline H Wood and Virginia W Wade of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, we, the said Adeline H Wood and Virginia W Wade in and by our certain note or obligation, bearing date the day of October 1926

we are indebted unto The Carolina Loan and Trust Company of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Thirty three hundred & no. (\$3300) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the day of October A. D. 1926,

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that we the said Adeline H Wood and Virginia W Wade shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of November 1926,

and on the 20th or before the end of each month thereafter for forty successive months, the sum of \$38.50 Dollars, \$16.50 Dollars,

being the regular monthly installment payable on the thirty-three (33) Shares of Stock, and \$22.00 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of \$34.10 Dollars, (\$16.50 Dollars,

Dollars, being the regular monthly payment on said stock and \$16.50 Dollars, being the monthly interest on balance due); for the next twenty months the sum of \$29.70 Dollars, (\$16.50 Dollars,

Dollars, being the regular monthly payment on said stock and \$13.20 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of the Balance Remaining Due and unpaid to be payable (on the last day of the one hundredth (100th) month.

Dollars, being the monthly payment on said shares of stock and Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Dollars, ( Dollars, being the monthly interest on balance due.)

Each of the above payments to be made, on the 20th or before the last day of each month, and shall hereafter surrender to the Company the said 33 shares of stock and the certificate thereof, the amount at such time paid shares by us to be credited as a payment upon the advance or loan made. we, the said Adeline H Wood and Virginia W Wade

and shall pay or cause to be paid all fines which may be duly imposed upon or charged against us, the said Adeline H Wood and Virginia W Wade in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunto written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN That we, the said Adeline H Wood and Virginia W Wade in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to us

the said Adeline H Wood and Virginia W Wade in hand well and truly paid by the said The Carolina Loan and Trust Company at and before the sealing and delivery of these presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

all that lot of land in Greenville Township, Greenville County, South Carolina, on the east side of Hammond and on north side of Rhett Street, in City of Greenville, and more particularly described as follows: Beginning at an iron pin at the northeast corner of intersection of said Hammond and Rhett Streets and running thence with Hammond Street N. 27-40 W. 164.5 feet more or less, to stake at corner of lot, No. 16, as shown on plat recorded in Deed, Book 33, page 482, thence along line of said lot N. 62-45 E. 210 feet, more or less, to stake in center of E & W. C. Railway track, thence in a southerly direction with the center of said track, off the line, 70 feet, more or less, to Rhett Street; thence with said Street as the line S. 70-55 W. 231 feet more or less, to beginning, being the same corner to J. S. Boroughs by deed dated 1925, recorded in Book 86, page 1048.
