

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That *J. F. McNeely* of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *J. F. McNeely*, the said *J. F. McNeely* in and by *Myself* certain note or obligation, bearing date the *28th* day of *October* 192*6*

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Eight hundred & no/100 (\$800.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the *28* day of *October* A. Dollars, (*\$8.00*) Dollars, being the regular monthly installment payable on the *Eight (8)* Shares of Stock, and *\$5.33* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *\$12.27* Dollars, (*\$8.00*)

Dollars, being the regular monthly payment on said stock and *\$4.27* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *\$11.20* Dollars, (*\$8.00*)

Dollars, being the regular monthly payment on said stock and *\$3.20* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *\$10.13* Dollars, (*\$8.00*)

Dollars, being the monthly payment on said shares of stock and *\$2.13* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *\$9.07* Dollars, (*\$8.00*)

Dollars, being the monthly payment on said shares of stock and *\$1.07* Dollars, being the monthly interest on balance due.) McNeely* in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:
