TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I Lula A. Williams
 of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
 WHEREAS, *I*, the said *Lula A. Williams*
 in and by *my* certain note or obligation, bearing date the *October* day of *1926*
I am indebted unto *The Carolina Loan and Trust Company*, of the City and County of Greenville, in said State (a body corporate,
 duly incorporated under the laws of such State) in the sum of *Five hundred & no (\$1,000.00)* Dollars,
 with interest thereon at the rate of eight per centum per annum, payable monthly, from the day of *October* A. D. 1926,
 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
 the said *Lula A. Williams* shall pay or cause to be paid to the said
 Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *November*
 1926, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *\$16.67*
 Dollars, (*\$10.00*) Dollars,
 being the regular monthly installment payable on the *Shares of Stock*, and *5.67*
 Dollars, being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the
 sum of *\$15.33* Dollars, (*\$10.00*) Dollars, being the monthly interest on balance due);
 Dollars, being the regular monthly payment on said stock and *5.33* Dollars, being the monthly interest on balance due);
 for the next twenty months the sum *\$14.00* Dollars, (*\$10.00*) Dollars, being the regular monthly payment on said stock and *4.00*
 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *\$12.67*
 Dollars, (*\$10.00*) Dollars, being the monthly payment on said shares of stock and *2.67*
 sum of *\$11.33* Dollars, (*\$10.00*) Dollars, being the monthly interest on balance due); for the next twenty months pay the
 monthly payment on said shares of stock and *1.33* Dollars, (*\$10.00*) Dollars, being the monthly interest on balance due.)
 Each of the above payments to be made on the 20th or before the last day of each month and shall thereafter surrender to the Company the said *Five (5)*
 shares of stock and the certificate thereof, the amount at such time paid shares by *me* to be credited as a payment upon the advance or loan made *to me*, the said
Lula A. Williams
 and shall pay or cause to be paid all fines which may be duly imposed upon or charged against the said
Lula A. Williams
 in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the
 said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.
 NOW KNOWN ALL MEN, That *I* the said *Lula A. Williams*
 in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,
 according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *me*
 the said *Lula A. Williams*
 in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is
 hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and
 Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Known and designated as lot no. 17 of Block "B", as shown on plat of Sterling Annex property, said plat being recorded in Plat Book "B" at page 9, said lot being situate just beyond the limits of the City of Greenville, in the County and State aforesaid, and having the following metes and bounds, to wit:-- Beginning at a stake on the South side of Sterling Street 15.6 feet from the corner of Sterling Street and Myrus Street; thence S. 25-15 E. with line of Sterling Street 50 feet to corner of lot no. 16; thence with line of lot no. 16, S. 57 W. 158.6 feet, to an iron pin corner of Lots nos. 8, 9 and 16; thence with line of lot no. 9, N. 25-10 W. 59 feet, to an iron pin; thence N. 57 E. 158.5 feet to the beginning corner, and being the same lot of land conveyed to me by Joseph Williams, and others, by deed dated March 10th, 1926, and recorded in Deed Book 124, Page 310, R. M. C. office for Greenville County, South Carolina.
