

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Anna Scott Ladson
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Anna Scott Ladson
in and by my certain note or obligation, bearing date the 2nd day of March 1927

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Twelve Hundred and ^{no} 00 Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 2nd day of March A. D. 1927, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I

the said Anna Scott Ladson shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of April 1927, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Twenty and ^{no} 00 Dollars, (Twelve Dollars,

being the regular monthly installment payable on the Twelve Shares of Stock, and Eight and ^{no} 00 Dollars, being the monthly interest on the advance (or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Eighteen and ^{no} 00 Dollars, (Twelve Dollars, being the regular monthly payment on said stock and Six and ^{no} 00 Dollars, being the monthly interest on balance due);

for the next twenty months the sum of Thirteen and ^{no} 00 Dollars, (Twelve Dollars, being the regular monthly payment on said stock and One and ^{no} 00 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Four and ^{no} 00 Dollars, (Twelve Dollars, being the regular monthly payment on said stock and Eight and ^{no} 00 Dollars, being the monthly interest on balance due);

for the next twenty months pay the sum of Five and ^{no} 00 Dollars, (Twelve Dollars, being the regular monthly payment on said stock and One and ^{no} 00 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twelve Dollars, (Twelve Dollars, being the regular monthly payment on said stock and Zero and ^{no} 00 Dollars, being the monthly interest on balance due.);

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Twelve shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the said Anna Scott Ladson

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said Anna Scott Ladson in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said Anna Scott Ladson in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

the said Anna Scott Ladson in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Greenville Township
Beginning at a stake on North Side of
old Paris Mountain Road, 80 feet from
Scott's Alley; and running with old Paris
Mountain Road S. 23-15 E. 75 feet to a stake;
thence N. 66-45 E. 150 feet to an iron pin; thence
N. 23-15 E. 75 feet to an iron pin; thence S.
66-45 E. 150 feet to the beginning corner.
Being a portion of that land conveyed
to me by deed of Ed. Scott, dated Dec.
1918, and recorded in Vol 58 page 20, R.M.C.
Office for said Greenville County and
inherited from my father Gabriel Scott,
deceased.
