

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I Carrie Williams of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, my certain note or obligation, bearing date the 9th day of June 1927

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State, a body corporate, duly incorporated under the laws of such State, in the sum of Fifteen hundred and thirty five Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 7th day of June A. D. 1927, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said Carrie Williams shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of June 1927, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Twenty Three and 1/100 Dollars,

being the regular monthly installment payable on the 15 1/2 Shares of Stock, and Twenty Three and 1/100 Dollars, ( 15.50 Dollars, being the regular monthly payment on said stock, and Eight and 2/100 Dollars, being the monthly interest on balance due);

for the next twenty months the sum of Twenty one and 7/100 Dollars, ( 15.50 Dollars, being the regular monthly payment on said stock and Six and 2/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Nineteen and 4/100 Dollars,

( 15.50 Dollars, being the regular monthly payment on said shares of stock and Four and 1/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Seventeen and 5/100 Dollars, ( 15.50 Dollars, being the regular monthly payment on said shares of stock and Two and 5/100 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 15 1/2 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me the said Carrie Williams

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said Carrie Williams in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had more fully appearing.

NOW, KNOW ALL MEN, That Carrie Williams in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

the said Carrie Williams in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the making and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

"all that lot of land in the City of Greenville, Greenville County, South Carolina beginning on the west side of Calhoun Street 86 feet from corner of Wumber and Calhoun Streets; thence along Calhoun Street southerly 43 feet to corner of lot of Young; thence westerly along Young's line 100 feet; thence northerly parallel to Calhoun Streets 43 feet to Holloway's lot; thence along Holloway's line easterly 100 feet to the beginning corner, being the same lot conveyed to Julia Gardner by D. W. Cochran and E. G. Webster, deed recorded in Book 71, page 563 Being the same lot of land conveyed to me by E. Inman, Master, deed dated June 19, 1927 yet to be recorded
