WHEREAS the said *Blairice L. Lacey* has been indebted to the said *The Carolina Loan and Trust Company*, of the City and County of Greenville, in said State, a body corporate, duly incorporated under the laws of such State, in the sum of *Eighteen hundred and no/100* Dollars, with interest thereon at the rate of *eight per centum per annum*, payable monthly, from the *6th* day of *July*, A. Lacey* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *July*, 192*7*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *thirty and no/100* Dollars, being the regular monthly installment payable on the *18* Shares of Stock, and *twelve and no/100* Dollars, being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Twenty and no/100* Dollars, being the regular monthly payment on said stock and *nine and 60/100* Dollars, being the monthly interest on balance due; for the next twenty months the sum of *Twenty five and 20/100* Dollars, being the regular monthly payment on said stock and *seven and 20/100* Dollars, being the monthly interest on balance due; for the next twenty months pay the sum of *Twenty two and 80/100* Dollars, being the monthly payment on said shares of stock and *eighteen* Dollars, being the monthly interest on balance due; for the next twenty months pay the sum of *Twenty and 40/100* Dollars, being the monthly payment on said shares of stock and *eighteen* Dollars, being the monthly interest on balance due.
