

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I Frank S. White Jr. of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, Frank S. White, Jr. in and by my certain note or obligation, bearing date the 29th day of July 1927

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Three hundred fifty and no/100 Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 29th day of July A. D. 1927

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I the said Frank S. White, Jr. shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of August 1927, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Five and 8/100 Dollars, (\$ 3.50

Dollars, being the regular monthly installment payable on the 3 1/2 Shares of Stock, and Two and 34/100 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Five and 36/100 Dollars, ( 3.50

Dollars, being the regular monthly payment on said stock and One and 86/100 Dollars, being the monthly interest on balance due); for the next twenty months the sum of Four and 99/100 Dollars, ( 3.50

Dollars, being the regular monthly payment on said stock and one and 49/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Four and 44/100 Dollars, ( 3.50

Dollars, being the monthly payment on said shares of stock and Three and 94/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Three and 46/100 Dollars, ( 3.50

Dollars, being the monthly payment on said shares of stock and Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 3 1/2 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me the said Frank S. White, Jr.

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said Frank S. White, Jr. in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said Frank S. White, Jr. in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

the said Frank S. White, Jr. in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All that certain lot of land, in city of Greenville Greenville County, South Carolina, beginning at the Thompson's corner on Green Avenue, and running thence with Green Avenue 139 feet to Adolphus Frazier's corner; thence N. 12 E. 39 feet to Lulu Thompson's corner; thence S. 77 E. 150 feet to the beginning corner.
