

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, G.A. Cagle

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said G.A. Cagle

in and by my certain note or obligation, bearing date the 3rd day of August 1927

am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Nine hundred (\$900.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 3rd day of August A. D. 1927, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I the said G.A. Cagle shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of Aug 1927, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of fifteen and no/100 Dollars, (Nine and no/100 Dollars, being the regular monthly installment payable on the nine Shares of Stock, and Six and no/100 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Thirteen and 80/100 Dollars, (Nine and no/100 Dollars, being the regular monthly payment on said stock and four and 80/100 Dollars, being the monthly interest on balance due); for the next twenty months the sum of Twelve and 60/100 Dollars, (Nine and no/100 Dollars, being the regular monthly payment on said stock and three and 60/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eleven and 40/100 Dollars, (Nine and no/100 Dollars, being the monthly payment on said shares of stock and Two and 40/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Ten and 20/100 Dollars, (Nine and no/100 Dollars, being the monthly payment on said shares of stock and one and 20/100 Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said nine shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the said G.A. Cagle

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said G.A. Cagle

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, that I the said G.A. Cagle

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said G.A. Cagle

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In Greenville Township, in a subdivision of H.B. Bates land, plat of which subdivision is of record in the G.M.C. Office for Greenville County in Plat Book F. page 32, and having the following courses and distances: Beginning at an iron pipe on the corner of Bates and Center Streets and running thence with Bates Street S. 55-40 E. 50 feet to iron pin, corner of lot No. 17; thence with line of said lot S. 48-30 W. 150 feet to iron pin, corner of lot No. 18; thence with line of said lot N. 55-40 W. 50 feet to an iron pin on Center Street; thence with Center Street N. 48-30 E. 150 feet to the beginning corner; and being the same conveyed to me by deed of W.C. Whitworth, dated Feb. 2, 1927, and recorded in the R.M.C. Office aforesaid in Deed Book ---- page ----. The above lot is designated on said plat and named in said deed as Lot No. 19.
