

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, *Olin M. McKae*

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, *Olin M. McKae*, the said *Olin M. McKae* in and by *my* certain note or obligation, bearing date the *1st* day of *November* 192*7*

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Eleven hundred and no/100* Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the *11th* day of *November* A. D. 192*7*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said *Olin M. McKae* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *December* 192*7*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Eighteen and 3/100*

Dollars, (*Eleven* Dollars, being the regular monthly installment payable on the *11th* Shares of Stock, and *Seven and 3/100*

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Sixteen and 86/100* Dollars, (*Eleven*

Dollars, being the regular monthly payment on said stock and *Five and 86/100* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *Eighteen and 48/100* Dollars, (*Eleven*

Dollars, being the regular monthly payment on said stock and *Four and 4/100* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Thirteen and 94/100*

Dollars, (*Eleven* Dollars, being the monthly payment on said shares of stock and *Two and 94/100*

Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Three and 50/100* Dollars, (*Eleven* Dollars, being the monthly payment on said shares of stock and *Four and 50/100*

Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *11* shares of stock and the certificate thereof, the amount at such time paid shares by *me* to be credited as a payment upon the advance or loan made *me* the said

*Olin M. McKae* and shall pay or cause to be paid, all taxes which may be duly imposed upon, or charged against *me*, the said *Olin M. McKae*

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, *Olin M. McKae* the said *Olin M. McKae* in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars *me*

the said *Olin M. McKae* in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In Greenville Township, in said subdivision known as Sans Souci Annex, and being designated as lot no 38 on plat of said sub-division, plat recorded in the R. M. C. office for Greenville County in Plat Book C, page 29, and having the following metes and bounds: Beginning at an iron pin on the n. w. side of Inturban Avenue, 50 feet n. e. from Lee Street, corner of lot no. 37, and running thence with line of lot no. 37, n. 42-20 feet. 157.5 feet to an alley; thence with said alley n. 42.20 E. 50 feet to an iron pin, corner of lot no 39; thence with line of said lot S. 84.20 E. 157.5 feet to an iron pin on Inturban Avenue; thence with said Avenue S. 42.40 W. 50 feet to the beginning corner, and Being the same conveyed to me by deed recorded in the R. M. C. office aforesaid in Deed Book 130, page 175.
