TO ALL WHOM THESE PRESENTS MAY CONCERN:

*L. M. Stewart*  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *L. M. Stewart*, the said *L. M. Stewart*  
in and by *my* certain note or obligation, bearing date the *18th* day of *April* 192*8*

indebted unto The Carolina Loan and Trust Company of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Three Thousand (\$3,000.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the *18th* day of *April* A. D. 192*8*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said *L. M. Stewart* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *May* 192*8*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Forty seven & 5/100 (\$47.50)* Dollars, (*Thirty (\$30.00)* Dollars,

being the regular monthly installment payable on the *Thirty* Shares of Stock, and *Seventeen & 5/100 (\$17.50)* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Forty four (\$44.00)* Dollars, (*Thirty (\$30.00)* Dollars, being the regular monthly payment on said stock and *Fourteen & 5/100 (\$14.50)* Dollars, being the monthly interest on balance due);

for the next twenty months the sum of *Forty & 5/100 (\$40.50)* Dollars, (*Thirty (\$30.00)* Dollars, being the regular monthly payment on said stock and *Ten & 5/100 (\$10.50)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Thirty seven (\$37.00)* Dollars, (*Thirty (\$30.00)* Dollars, being the monthly payment on said shares of stock and *Seven & 5/100 (\$7.50)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Thirty three & 5/100 (\$33.50)* Dollars, (*Thirty (\$30.00)* Dollars, being the monthly payment on said shares of stock and *Three & 5/100 (\$3.50)* Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall the said *L. M. Stewart* surrender to the said Company the said *thirty* shares of stock and the certificate thereof of the amount at such time paid shares by *me* to be *recorded* as a payment upon the advance or loan made *me* the said *L. M. Stewart* and shall pay or cause to be paid all fines which may be duly imposed upon, *charged* against *me* the said *L. M. Stewart*, in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had with more fully appear.

NOW, KNOW ALL MEN, That *L. M. Stewart* the said *L. M. Stewart* in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *me* the said *L. M. Stewart* in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

*All that certain piece, parcel or lot of land known and designated as Lot No. 10 of the C. B. Martin subdivision as shown on a plat of said property made by R. E. Dutton & Co., and recorded in the R. M. C. office for Greenville County in Plat Book "7" at page 102 and being more particularly described as follows:*  
*Beginning at an iron pin on the south side of Argonne Drive, joint corner of Lots 10 and 11 and running thence N. 48-50 E. 175 feet to an iron pin on the line of lot No. 7; thence along the line of lot No. 7 S. 41-10 E. 75 feet to an iron pin joint corner of lots 9 and 10; thence S. 48-50 W. 175 feet to an iron pin on Argonne Drive; thence along the south side of Argonne Drive N. 41-10 W. 75 feet to the beginning corner and being the same plot of land conveyed to L. M. Stewart by C. B. Martin by deed dated April 12, 1928, to be recorded.*
