

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, *Offie L. Bridges* of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *Offie L. Bridges*, the said *Offie L. Bridges* in and by *my* certain note or obligation, bearing date the *17th* day of *September* 192*8* indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *thirty five hundred (\$3500.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the *17th* day of *September* A. D. 192*8*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

*Offie L. Bridges* the said *Offie L. Bridges* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *October* 192*8*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *fifty five & 42/100 (\$55.42)* Dollars, (*\$35.00* Dollars, being the regular monthly installment payable on the *thirty five* Shares of Stock, and *Twenty & 42/100 (\$20.42)* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *fifty one & 33/100 (\$51.33)* Dollars, (*\$35.00* Dollars, being the regular monthly payment on said stock and *sixteen & 33/100 (\$16.33)* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *forty seven & 25/100 (\$47.25)* Dollars, (*\$35.00* Dollars, being the regular monthly payment on said stock and *twelve & 25/100 (\$12.25)* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *forty three & 17/100 (\$43.17)* Dollars, (*\$35.00* Dollars, being the regular monthly payment on said stock and *eight & 17/100 (\$8.17)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *thirty nine & 11/100 (\$39.11)* Dollars, (*\$35.00* Dollars, being the regular monthly payment on said stock and *four & 11/100 (\$4.11)* Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *35* shares of stock and the certificate thereof, the amount at such time paid shares by *me* to be credited as a payment upon the advance or loan made *me* the said

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against *me* the said *Offie L. Bridges* in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation thereunder written, reference hereunto had will more fully appear.

NOW KNOW ALL MEN, that *Offie L. Bridges* the said *Offie L. Bridges* in consideration of the debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also of consideration of the further sum of Five Dollars to *me* the said *Offie L. Bridges* in hand well and lawfully paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

*Lynnson* on the west side of Markley Street and being lot No. 5 of a subdivision of land represented by a plat recorded in Plat Book 9, pages 164 and 165, in the R.M.C. office for said Greenville County, and a part of the land devised to Grace Watson Griffith and Charles Watson by their mother, under her will admitted to probate in said Greenville County and now on file in the Probate Office in Apt. 180, File 2, and a part of the homestead of the grand mother of said Grace Watson Griffith, and Charles Watson, who was Mrs. Rebecca J. Watson, the will of their mother, Mrs. Mamie P. Watson, was proved on April 9, 1923.

Said lot has the following metes and bounds: Beginning 153 feet south of the corner of Grace Street on the west side of Markley Street at the corner of Lot No. 6, and running thence S. 71-06 N. 120.3 feet to the corner of Lot No. 11; thence S. 18-02 E. 51 feet to the corner of lot No. 13; thence N. 71-06 E. 120.4 feet to Markley Street, and to corner to corner of Lot No. 4; thence with Markley Street 51 feet to the beginning corner.
