of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *W. B. Bidwell* the said *W. B. Bidwell* in and by *my* certain note or obligation, bearing date the *17th* day of *November* 192*8* indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of said State), in the sum of *one thousand (\$1,000.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the *17th* day of *November* A.
