WHEREAS, I, A. F. McKissick

in and by my certain promissory note in writing, of even date with these presents,

am well and truly indebted to SOUTHEASTERN LIFE INSURANCE COMPANY,

a corporation chartered under the laws of the State of South Carolina, in the full and just sum of Twelve Thousand five hundred

\$12,500.00 DOLLARS, to be paid at its principal office in Greenville, S. C.

five (5) years after date

with interest thereon from date September 19, 1932, at the rate of six (6%) per cent. per annum, to be

computed and paid semi-annually on the 8th day of Sept. & March.

in each year until paid in full; if interest not paid when due to bear interest at the same rate as principal and any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including ten

per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land situate, lying and being

in the City of Greenville, County of Greenville, State of South Carolina, on the South-

west corner of the intersection of College Street and a ten foot alley, and being describ-

ed, according to survey thereof made by C. M. Furman, Jr., Engineer, on February 12th,

1925, as follows:

Beginning at an iron pin on the Southside of College Street, 60 feet

in an Easterly direction from the intersection of College and Laurens Streets, and run-

ning thence with College Street, S 55° 55' E. 40.9 feet to an iron pin on the West side

of a ten foot alley; thence with the Western line of said alley, S 20° 45' W. 80 feet to

an iron pin at the intersection of said ten foot alley with a ten foot blind alley; thence

with the Northern side of said ten foot blind alley, N. 55° 55' W. 41.35 feet to an iron

pin; thence N. 21° 05' E. 80 feet to the beginning corner. Also all of the mortgagor's

interest in and to said ten foot blind alley along the rear of the above described lot.

Together with the right, privilege and easement to tie on to the face

of the Eastern wall of the building of Marion Brawley, fronting on Laurens Street., Con-
