

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Lydia E. White of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, Lydia E. White, the said Lydia E. White, in and by my certain note or obligation, bearing date the 27th day of April 1927

in the sum of Four hundred and no Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 1st day of March A. D. 1927

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that the said Lydia E. White shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of April 1927

and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Six and 1/100 Dollars, being the regular monthly installment payable on the Four Shares of Stock, and Two and 67/100 Dollars, being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Six and 1/100 Dollars, being the regular monthly payment on said stock and Two and 1/100 Dollars, being the monthly interest on balance due;

for the next twenty months the sum of Four and 60/100 Dollars, being the regular monthly payment on said stock and Five and 60/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Five and 60/100 Dollars, being the monthly payment on said shares of stock and Five and 60/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Four and 60/100 Dollars, being the monthly payment on said shares of stock and Five and 60/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Four and 60/100 Dollars, being the monthly payment on said shares of stock and Five and 60/100 Dollars, being the monthly interest on balance due);

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said four shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as payment upon the advance or loan made the said Lydia E. White and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto and will more fully appear.

NOW, KNOW ALL MEN, That I, Lydia E. White, the said Lydia E. White, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Lydia E. White

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt hereof is hereby acknowledged), have granted, bargained, sold and conveyed, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

"And in the City of Greenville, on [unclear] Alley having a frontage on said Alley for 71 feet and a depth of 245 feet on one side and 220 feet on the other side, and running back to the S. Railroad, [unclear] land conveyed to me by [unclear] dated October 5, 1925 and recorded in [unclear] Book 98, page 444, R. M. C. office for said Greenville County."
