

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Harriet H. McAllister of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Harriet H. McAllister in and by my certain note or obligation, bearing date the 3rd day of May 1927

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Five Thousand and no/100 Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 3rd day of May A. D. 1927, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I

the said Harriet McAllister shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of May 1927, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Eighty three and 34/100

Dollars, (Fifty Dollars, being the regular monthly installment payable on the Fifty Shares of Stock, and Thirty Three and 34/100 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Seventy Six and 66/100 Dollars, (Fifty Dollars, being the regular monthly payment on said stock and Twenty Six and 66/100 Dollars, being the monthly interest on balance due);

for the next twenty months the sum of Seventy Six and no/100 Dollars, (Fifty Dollars, being the regular monthly payment on said stock and Twenty and no/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Sixty three and 34/100 Dollars, (Fifty Dollars, being the monthly payment on said shares of stock and Thirteen and 34/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Fifty six and 66/100 Dollars, (Fifty Dollars, being the monthly payment on said shares of stock and Six and 66/100 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Fifty shares of stock and the certificate thereof, the amount at such time paid to be credited as a payment upon the advance or loan made. me the said Harriet H. McAllister

and shall pay or cause to be paid all taxes which may be duly imposed upon, or charged against me the said Harriet H. McAllister in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereon or written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That Harriet H. McAllister in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Harriet H. McAllister

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

all that certain lot of land in Greenville Township, Greenville County, South Carolina, being lot No. 35 on plat 1 of Park Hill property of Mrs. J. O. Lewis, recorded in the R. M. C. Office for Greenville County in Plat Book F, page 136, and having the following metes and bounds:-

Beginning on south side of Clew Street at corner of lot No. 12; thence with said street N. 62-50 E. 90 feet to corner of lot No. 15; thence with line of that lot S. 27-10 E. 140 feet to a stake in line of lot No. 36; thence with line of that lot S. 62-50 E. 90 feet to the joint corner of lots 14 and 13; thence with line of lots 13 and 12 N. 27-10 E. 149 feet to the beginning corner, being same lot conveyed to me by Mary B. Lewis, deed dated April 21, 1927, and recorded in Deed Book 104, page 531, R. M. C. Office for said Greenville County.
