

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, A. W. Kennemore of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said A. W. Kennemore in and by my certain note or obligation, bearing date the 19th day of July 1927

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Two hundred Fifty and no/100 Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 19th day of July A. D. 1927, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said A. W. Kennemore shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of August 1927, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Sixty and 67/100 Dollars, ( Sixty and 67/100 Dollars,

being the regular monthly installment payable on the 2 1/2 Shares of Stock and one and 67/100 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Sixty and 33/100 Dollars, ( Five Dollars, being the regular monthly payment on said stock and one and 33/100 Dollars, being the monthly interest on balance due); for the next twenty months the sum of Five Dollars, ( Five Dollars, being the regular monthly payment on said stock and one and no/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Five and 67/100 Dollars, ( Five Dollars, being the monthly payment on said shares of stock and 67/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Five and 33/100 Dollars, ( Five Dollars, being the monthly payment on said shares of stock and 33/100 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 2 1/2 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the said A. W. Kennemore

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against, the said A. W. Kennemore in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, that I the said A. W. Kennemore in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said A. W. Kennemore

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

as to that certain lot of land in Greenville Township, Greenville County, South Carolina being lot no. 2 of Block D according to plat in Plat Book A, page 327 K.M.C. office for said Greenville County. Said lot has a frontage of fifty feet on east side of Y. M. C. A. Street and a depth of two hundred fifty feet on the south side and is the same lot which was conveyed to me by A. G. New, deed dated February 15, 1919, recorded in Deed Book 45, page 2 of 3, said K.M.C. office.
