TO ALL WHOM THESE PRESENTS MAY CONCERN:

M. W. White and Josephine White
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, *we*, the said *M. W. White and Josephine White*
in and by *ourselves* certain note or obligation, bearing date the *25th* day of *July* 192*7*
are indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of *Nine Hundred Fifty (\$950.00)* Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the *25th* day of *July* A. D. 192*7*,
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that *we*
the said *M. W. White and Josephine White* shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *August*
192*7*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Fifteen and 84/100*
Dollars, (*Nine and 50/100* Dollars,
being the regular monthly installment payable on the *Nine and 50/100* Shares of Stock, and *Six and 34/100*
Dollars, being the monthly interest on the advance or loan) and that we have been paid twenty monthly payments, and shall for the next twenty months pay the
sum of *Fourteen and 56/100* Dollars, (*Nine and 90/100*
Dollars, being the regular monthly payment on said stock and *Five and 60/100* Dollars, being the monthly interest on balance due);
for the next twenty months the sum of *Nine and 50/100* Dollars, being the regular monthly payment on said stock and *Three and 80/100*
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Seven and 31/100*
Dollars, (*Nine and 50/100* Dollars, being the monthly payment on said shares of stock and
Two and 34/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the
sum of *Ten and 77/100* Dollars, (*Nine and 50/100* Dollars, being the monthly payment on said shares of stock and
One and 27/100 Dollars, being the monthly interest on balance due.)
Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *Nine and 1/2*
shares of stock and the certificate thereof, the amount at such time paid shares by *us* to be credited as a payment upon the advance or loan made *us* by the said
Company, and shall pay or cause to be paid all taxes which may be duly imposed upon, or charged against *us* the said *M. W. White*
and Josephine White in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the
said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.
NOW, KNOW ALL MEN, That *Five* the said *M. W. White and Josephine White*
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *us*
the said *M. W. White and Josephine White*
in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the signing and delivery of these Presents, (the receipt whereof is
hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said The Carolina Loan and
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In Greenville Township, about one and one-half miles from the City of Greenville, near the Southern Railway, described as follows: Beginning at an iron pin three hundred seven feet from the N.W. corner of Goldsmith and Henry Streets, corner of lot No. 67 on plat hereinafter referred to, and running thence N. 48-30 E. 183 feet to an iron pin on a 14 foot alley; thence with said alley N. 41-30 W. 61 feet to an iron pin corner of lot No. 65; thence with line of said lot No. 65, S. 48-30 W. 183 feet to an iron pin on Henry Street; and thence with Henry Street S. 41-30 E. 61 feet to the beginning corner, being Lot No. 66 on plat of Oakwood, recorded in the R.M.C. Office for Greenville County in Plat Book A, page 424, and being the same lot conveyed to us by deed recorded in the R.M.C. Office aforesaid in Deed Book 25, page 192.

Also, all those certain lots or parcels of land situate in the Township, County and State aforesaid, on the Paris Mt. Road, near the City of Greenville, designated as Lots Nos. 33 and 34 on plat of Perry Estate, plat recorded in the office aforesaid in Plat Book F, at page 127, and having the following courses and distances: Beginning at an iron pin on Paris Mt. Road, joint corner of lots Nos. 34 and 35, and running thence with the Paris Mt. Road N. 21-52 W. 152.12 feet to an iron pin, corner of Sidney Street and Paris Mt. Road; thence with Sidney Street S. 58-30 W. 191.6 feet to an iron pin corner of lot No. 32; thence along line of lot No. 32, S. 31-30 E. 150 feet to an iron pin; thence N. 58-30 E. 166.3 feet to the beginning corner, and

Also all that certain lot or parcel of land situate in the Township, County and State aforesaid, designated on the plat aforesaid as lot No. 32, described as follows: Beginning at an iron pin on the south side of Sidney Street, joint corner of lots Nos. 33 and 32, and running thence with Sidney Street S. 58-30 W. 50 feet to an iron pin, joint corner of lots Nos. 31 and 32; thence along line of lot No. 31, S. 31-30 E. 150 feet to an iron pin; thence N. 58-30 E. 50 feet to an iron pin, corner of lot No. 34; thence along line of lots 33 and 34 N. 31-30 W. 150 feet to the beginning corner; and,

This lot, and the lots immediately described above, are the same conveyed to M.W. White by deed recorded in the office aforesaid in Deed Book 90, page 33.
