

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Mrs. Nellie M. Millon of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, Mrs. Nellie M. Millon in and by my certain note or obligation, bearing date the 28th day of July 1927

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Two hundred and fifty Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 28th day of July A. D. 1927, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said Mrs. Nellie M. Millon shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of August 1927

and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Four and 17/100 Dollars, (Two and 50/100 Dollars,

being the regular monthly installment payable on the 2 1/2 Shares of Stock, and One and 67/100 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Three and 83/100 Dollars, (Two and 59/100 Dollars,

being the regular monthly payment on said stock and one and 33/100 Dollars, being the monthly interest on balance due); for the next twenty months the sum of Three and 50/100 Dollars, (Two and 59/100 Dollars,

being the regular monthly payment on said stock and one and 20/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Three and 17/100 Dollars, (Two and 50/100 Dollars,

being the monthly payment on said shares of stock and 67/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Two and 83/100 Dollars, (Two and 59/100 Dollars,

being the monthly payment on said shares of stock and 33/100 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 2 1/2 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me the said Mrs. Nellie M. Millon

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said Mrs. Nellie M. Millon

in accordance with the Charter, By-Laws, Rules and Regulations as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, Mrs. Nellie M. Millon in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof unto the said The Carolina Loan and Trust Company,

according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to the said Mrs. Nellie M. Millon in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

"In Greenville Township, near the city of Greenville, designated as lot no. 29 of the M. C. Baley land, Plat of which is of record in the R. M. L. office for said County in Plat Book A. Pages 278 and 279, and having a frontage of 66 feet on M. C. Baley Street with a depth on the west side of 123 feet, more or less, and 112 feet, more or less, on the east side; and, Being the same conveyed to me by deed recorded in the R. M. L. office aforesaid in Deed Book 98. Page 227."
