

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

The S. V. Thomason and Adell H. Thomason of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, The S. V. Thomason and Adell H. Thomason in and by our certain note or obligation, bearing date the 19th day of August 1927

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Seventeen Hundred and no Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly from the 19th day of August A. D. 1927, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that we

the said S. V. Thomason and Adell H. Thomason shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of September 1927,

and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Twenty Eight and 34/100 Dollars, (Seventeen) Dollars, being the regular monthly installment payable on the 17 Shares of Stock, and Seven and 34/100

Dollars, being the monthly interest on the advance (or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Twenty Six and 26/100 Dollars, (Seventeen)

Dollars, being the regular monthly payment on said stock and Nine and 26/100 Dollars, being the monthly interest on balance due); for the next twenty months the sum of Twenty Three and 20/100 Dollars, (Seventeen)

Dollars, being the regular monthly payment on said stock and Six and 20/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twenty One and 54/100

Dollars, (Seventeen) Dollars, being the monthly payment on said shares of stock and Four and 54/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Nineteen and 26/100 Dollars, (Seventeen)

Dollars, being the monthly payment on said shares of stock and Two and 26/100 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 17 shares of stock and the certificate thereof, the amount at such time paid shares by us to be credited as a payment upon the advance or loan made by said

S. V. Thomason and Adell H. Thomason and shall pay or cause to be paid all fines, which may be duly imposed upon, or charged against us the said S. V. Thomason and Adell H. Thomason in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That we the said S. V. Thomason and Adell H. Thomason in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,

according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to us the said S. V. Thomason and Adell H. Thomason

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All that piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County and State of South Carolina, on the east side of Washington Ave., 473 feet north of the northeast intersection of Washington Ave. and Casley Bridge Road, at corner, of lot of Linnearnauger, and running thence N. 716.200 feet to a point in line of lot no 13; thence with line of lots 13 and 15, N. 22-10 W. 536/10 feet to point; thence S. 712.200 feet to a point on Washington Ave.; thence S. 22-10 E. 536/10 feet to the beginning corner, and,

Being a portion of lots 12 and 14 of Block D, as shown on plat recorded in the R. M. C. Office for said County in Plat Book C, 109; and, being a portion of the said lots conveyed to me by deed recorded in the R. M. C. Office aforesaid in Deed Book 96, page 191, and

Being the same conveyed to us by J. H. Hubbanks, deed dated August 11, 1927, to be recorded."
