TO ALL WHOM THESE PRESENTS MAY CONCERN:

*C. J. Mahaffey*  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting;  
WHEREAS, *C. J. Mahaffey*, the said *C. J. Mahaffey*  
in and by *my* certain note or obligation, bearing date the *23rd* day of *November* 192*7*  
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,  
duly incorporated under the laws of such State), in the sum of *Nine Hundred and 20/100* Dollars,  
with interest thereon at the rate of eight per centum per annum, payable monthly, from the *23rd* day of *November* A. D. 192*7*,  
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that  
the said *C. J. Mahaffey* shall pay or cause to be paid to the said  
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *December*  
192*7*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Fifteen and*  
*20/100* Dollars, (*Nine* Dollars,  
being the regular monthly installment payable on the *nine* Shares of Stock, and *Six and 20/100*  
Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the  
sum of *Thirteen and 80/100* Dollars, (*Nine* Dollars, being the regular monthly payment on said stock and *Four and 80/100* Dollars, being the monthly interest on balance due);  
for the next twenty months the sum of *Twelve and 90/100* Dollars, (*Nine* Dollars, being the regular monthly payment on said stock and *Three and 60/100*  
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Seven and 40/100*  
Dollars, (*Nine* Dollars, being the monthly payment on said shares of stock and *Two and 40/100* Dollars, being the monthly interest on balance due); for the next twenty months pay the  
sum of *Ten and 20/100* Dollars, (*Nine* Dollars, being the monthly payment on said shares of stock and *One and 20/100* Dollars, being the monthly interest on balance due.)  
Each of the above payments, to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *nine*

according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *me*

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is  
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and  
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

*All that certain lot of land in Greenville  
Township, Greenville County, South Carolina, begin-  
ning at corner of lot No. 5 subdivision of W. F.  
Nesbitt land, on the Cedar Lane Road and running  
thence N. 79-39 1/2. 40 feet; thence N. 10-44 1/2. 50 feet; thence  
S. 79-30 1/2. 40 feet to joint line of lots 5 and 6; thence  
along line of lot No. 5, 150 feet to the beginning  
corner, this is a part of lot no. 6 as represented  
on a plat recorded in Plat Book C, page 200,
